- When an electronic bill is generated, Electronic Billing automatically records the file creation date and time
- Users can enter supplemental tracking details such as invoice submission, approval dates and detailed comments
- To help troubleshoot issues, users can view a list of proformas that were included in the original finalized bill

## IMPROVE FIRM-WIDE VISIBILITY

- Electronic invoices are immediately available to authorized firm users
- If an electronic invoice is rejected by a client's bill validation application, a notification can be sent to the billing timekeeper

Embedded workflow capabilities allow firms to streamline, automate and track invoices. Once electronic invoices are generated in Electronic Billing, information is immediately available to authorized firm users. If an electronic invoice is rejected by a client's bill validation application, a notification can be sent to the billing timekeeper about the problem for review. And when an invoice becomes overdue, the collections department can be aware of any changes that were submitted and approved.
